This is a PMSR/RRA program with academics, surgery and clinical (inpatient/outpatient) care. The program has been active for over 38 years. This podiatric residency is based in a Veterans Affairs teaching hospital and is integrated with other allopathic residency programs with residents from the University of Colorado Health Sciences Center. Affiliated institutions include major hospitals and multiple surgery centers in metro Denver and Colorado Springs. There is a large volume of elective, emergent and reconstructive surgery, including instruction in arthroscopy and advanced techniques. Exposure to lower extremity biomechanics, diabetic foot care and wound care is integrated into the residency. Residents sign a yearly contract.

We will be moving to our new state-of-art facility in July, 2018.
