This is a PMSR/RRA residency experience and offers additional credentialing in Reconstructive Rearfoot & Ankle Surgery. The PGY-1 year is at Stroger Hospital of Cook County. During this year, the resident participates in an extremely busy clinic and in numerous surgical procedures, including podiatric, orthopedic, and trauma in a county hospital setting. There are additional rotations in Anesthesiology, Behavioral Sciences, Orthopedic Surgery, Pathology and Radiology.

The PGY-2 & 3 years are linked to Advocate Illinois Masonic Medical Center a large community hospital which sponsors 10 other residency programs and 3 Fellowship programs. The residents continue their training to increase proficiency in all areas of Podiatric Medicine and Surgery. There are rotations in Emergency Medicine, Infectious Diseases, Internal Medicine, Trauma Surgery, Orthopedic Surgery, and Rheumatology. There is also another Advocate hospital, and the University of Chicago where additional foot and ankle cases are covered.
