Residency is approved for reconstructive rearfoot and ankle surgery. Three positions are available each year. The program emphasizes core medical rotations with various medical sub specialties in the PGY-1 year. Reconstructive rearfoot/ankle surgery and limb salvage/ wound care are emphasized by participation of PGY-2 and PGY-3 residents in Kettering Hospital System and the Miami Valley (Premier) Hospital System located in Dayton Ohio. The Miami Valley Hospital is a level one trauma center. Extensive experience will be obtained treating all types of wounds and most wound care modalities are available to include hyperbaric oxygen. Elective outside office rotations are available with local practitioners as a third year resident. Ilizarov frame reconstruction as well as total ankle replacement surgery is under the instruction of Gary J. Labianco DPM who is a Podiatry Institute faculty member. Surgical experiences with limb salvage, plastic surgery and flap reconstruction are available at the Cincinnati VA with Suhail Masdeh, DPM who is fellowship trained in these techniques.
